Events are an important aspect of the work carried out by the Gulf Research Center (GRC) as they promote cooperation and link GRC to a worldwide network of leading individuals and research initiatives. Events play a key role for the

Events play a key role for the GRC in the Gulf region as they facilitate mutual research activities amongst various Gulf institutions and neighboring regions to raise knowledge of important Gulf-specific justices

GRC in the Gulf region as they facilitate mutual research activities amongst various Gulf institutions and neighboring regions to raise knowledge of important Gulf-specific issues. The Gulf Research Center is active in organizing conferences. lectures. meetings. seminars. symposiums and workshops that complement its various research programs. These include a wide range of events related to its research work and of importance to the Gulf region. Such activities address a range of subjects that offer more insight and awareness on the Gulf region through detailed, unbiased and reliable forums for specialized research on a number of topics including: Foreign Relations, Economy & Energy, Labor Markets & Migration, Environmental Security & Sustainability, Politics & Society, as well as Security & Defense, also their ramifications addressing importance. The goal of these events is to create greater transparency and engagement between policy and academic communities. In addition, the activities of the GRC also focus on current debates and issues in the region and are intended to highlight these discussions. Topics are announced well in advance of each event to enable all those wishing to participate to register. Participation in some highly specialized events is by invitation only. The Gulf Research Center has organized more than 480 Events, with more than 35,000 participants in

more than 30 countries, 50 cities and 100 venues to date. In 2011, the GRC was rated the second most influential think tank in the Middle East by the annual Think Tank Survey of the University of Pennsylvania.

One of the center's key events that aligns with its mission to better understand the region is the annual Gulf Research Meeting (GRM) at the University of Cambridge, UK. This collaboration of GRC and the University of Cambridge inspires empirical research on Gulf issues in line with GRC's vision. From the initial GRM in 2010 to date, the have included: 127 outcomes workshops. presentation of 1900 papers with the participation of 34 institutions and 3358 individual participants, and the publishing of 52 volumes of research papers. The outreach goes far beyond the meetings themselves. Since its establishment, the GRM has also extended its geographical reach, with scholars and policy experts partaking from all around the world.

Fully cognizant of an emerging Gulf-Africa relationship, the Gulf Research Center focused on these mutual ties in one of its pivotal research programs in 2008 and designated the Gulf-Africa Forum as part of its flagship annual conference program. The Gulf and Africa Strategy Forum was successfully convened in Cape Town, South Africa, on February 24-25, 2009 under the theme 'The Gulf Developing New and Africa: а Strategic Partnership.' In addition to conventional allies such as the United States and Europe and developing ties with Asian countries, it is evident that the GCC countries will also look to Africa as a potential major economic and political partner. With this in mind, the purpose of this conference was to

improve the partnership between the GCC and Africa by providing an in-depth evaluation of the state of links and a strong outlook as to where the partnership may be going. Key leaders and government, business, personalities from academia, and media participated in the forum and speeches by H.H. Sheikh Abdullah bin Zayed Al Nahvan, Minister of Foreign Affairs of the United Arab Emirates; H.E. Abdullah Bin Ahmad Zainal Ali Reza, Minister of Commerce and Industry of the Kingdom of Saudi Arabia; the Honorable Mary Nagu, the Minister of Industry, Trade and Marketing of the Republic of Tanzania; H.E. Phandu T.C. Skelemani, Minister of Foreign Affairs of the Republic of Botswana; H.E. Antonio Fernando, Ministry of Industry and Trade of the Republic of Mozambique; Prof. Ekmeleddin Ihsanoglu. Secretary General of the Organization of the Islamic Conference and H.E. Tomaz Salomão, Executive Secretary of the Southern African Development Community, highlighted the various nuances of Gulf-Africa relations from a multidimensional perspective. All agreed that there was a need to focus on strengthening the strategic Gulf-Africa relations and to use the conference as a platform to take the relationship further. The good timing of the conference was highlighted by many, as both regions faced challenges and needed to find new opportunities and partners to recover from the global economic turmoil that existed at the time.

In 2010, under the patronage of the Custodian of the Two Holy Mosques King Abdullah Bin Abdulaziz, the Council of Saudi Chambers in partnership with the Gulf Research Center organized "The Gulf-Africa Investment Conference 2010 -Fostering Economic Relations" that was held in Riyadh, Kingdom of Saudi Arabia from December 4 to 5, 2010. Thereby, the Kingdom underlined the importance of the Gulf-Africa Investment Conference and stressed the commitment to develop the strategic relationship with the countries of the African continent. The Gulf-Africa Investment Conference brought together key leaders and personalities from government, business, academia and media to outline the issues and challenges facing more constructive economic and business-to-business relations between the key regions of Africa and the Gulf. The focus of the meeting was looking specifically into the various investment opportunities that had presented themselves - including the relevant strategies required to turn initial plans into more concrete actions. This included opportunities in areas such as agriculture, minerals and natural resources, energy, telecommunications and infrastructure, as well as tourism and trade development. In all of these instances, the Gulf-Africa Investment Conference was a unique gathering that added substance to much of the rhetoric about GCC-Africa ties.



The Jeddah Chamber of Commerce and Industry (JCCI) and the Gulf Research Center organized the 2010 Jeddah Economic Forum "The Global Economy in 2020." As the premier event in the Middle East, the 2010 Jeddah Economic Forum highlighted / the / strategies / required anticipated for global economic development and growth, and brought together leading businessmen decision-makers. experts. and academics that discussed the outlook for the world economy in the next ten years in the key sectors of banking and finance, energy and the environment, trade, agriculture, industry, education, health, and science and technology. Experts and officials debated whether the end of the global economic

crisis is in sight and recovery is gradually taking place. In contrast to looking at the implications and causes, the 2010 Jeddah Economic Forum focused beyond the crisis, at the shape and leading characteristics of the next phase of global growth. In 2013, the Gulf Research Center Foundation in Geneva organized the 1st GCC-Swiss Forum that was held at the InterContinental Hotel Geneva. This innovative event served to address the bilateral relations and identify multi-faceted prospects between Switzerland and the countries of the strategically critical Arabian Gulf region. The GCC-Swiss Forum brought together high-level representatives from both Switzerland and the Gulf region, including various ministers, members from the respective Chambers of Commerce, as well as GCC and Swiss business leaders. The keynote speakers of this event were H.E. Maj. Gen. Dr. Abdul Latif bin Rashid al Zayani, the Secretary General of the Gulf Cooperation Council and H.E. Dr. Didier

Burkhalter, the Vice President of Switzerland.

A prominent workshop titled "Understanding the Institutions and Policies of the EU and EU-GCC Relations" was organized by the Gulf Research Center and the European Commission in 2013. The workshop brought together twenty-seven students from six GCC countries to participate and contribute in the framework of the GRC project "Promoting Deeper EU-GCC relations" which provided training sessions to understanding between the GCC and EU regions. The students from the GCC were selected according to their fields of studies, either international relations or political studies, and for their interest in issues linked to the European Union. The group included undergraduate students, graduate students, and young professionals. Five students from Brussels were also selected for the program to give the GCC students a different viewpoint on EU issues and a better insight into student life in Europe. The training schedule was divided between lectures, informative sessions. meeting with professionals, and visits. This training provided GCC students opportunity to acquire deeper knowledge about the EU as well as to develop direct contacts with students from Europe, EU professionals and academics.

One of many important events that the Gulf Research Center Foundation organized was the GCC-Germany Business and Investment Forum, which took place at the Ritz-Carlton Hotel in Berlin, Germany from March 11-13, 2014, in partnership with the Arab-German Chamber of Commerce and Industry (Ghorfa) and with the support of the Federation of GCC Chambers of Commerce and Industry. This pioneering event demonstrated the multi-faceted prospects between the dynamic GCC region and Germany in the areas of banking and investment, industry, logistics and transport, construction, energy and water, retail, healthcare, education, and vocational training. Particular attention was paid to the overall economic relationship in order to identify new and emerging opportunities that will have an impact on the

outlook for GCC-Germany business relations. The event attracted around 300 participants from all sectors of the German and Gulf business communities and opened with speeches by the Minister of International Relations of the Republic of Germany and H.E Dr. Abdullatif Al-Zayani, Secretary-General of the Gulf Cooperation Council. The sessions of the event provided an excellent opportunity for networking between the respective government and business representatives. In addition, the forum aimed to identify the leaders of the next generation from both the GCC and Germany, addressing potential challenges and opportunities.
